In accordance with paragraph 7.6 of the JSE Debt Listings Requirements and in addition to the requirements of Section 75 of the Companies Act 71 of 2008 (the Act), FirstRand Bank Limited (FRB or the bank) board members' and prescribed officers' disclosures are provided quarterly before the group and the bank's board and board committee meetings. The disclosures include all personal financial interests and any business or other interest that could create a potential conflict of interest.

The bank is a wholly owned subsidiary of FirstRand Limited, which is a bank controlling company for the purposes of the South African Banks Act 1990.
