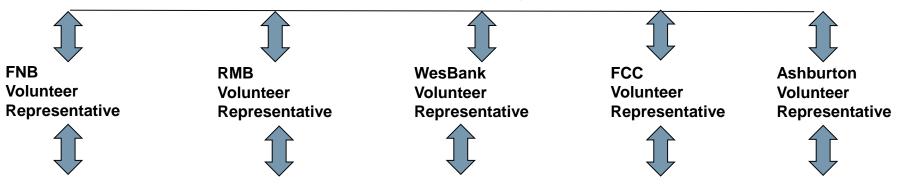

The Matched Funding Programme

- Matched Giving R1 for R1 (fundraisers,payroll giving, donations)
- Team Time 10 Employees
 8 hours together R5000
- Team Time 4-9 Employees 4 hours together – R2500
- Team Time Any size team 2 hours together – R2000
- Individuals accum. 8 hours R3000 to their charity

Money and time must come from employees before being matched

FirstRand Volunteer Group Drives – address NDP related issues, FirstRand gives money to staff to participate in these drives Staff don't need to give time/money first – maintains momentum

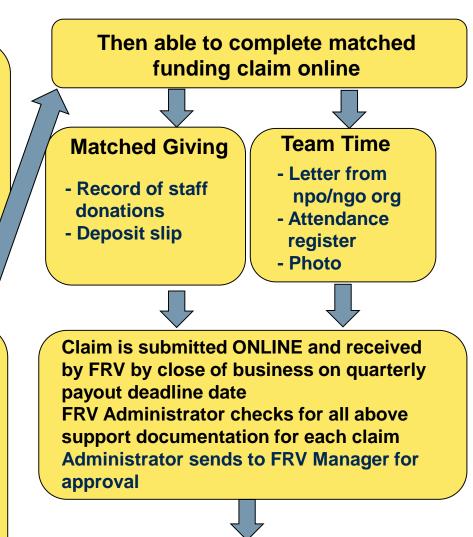
Teams <u>MUST</u> register volunteer groups and accounts (verified by Oracle and Hogan)

Volunteer accounts : Opened with authorisation by FRV business unit All accounts with RMB CB Have a relationship manager monitoring. These are business non-profit accounts Volunteers <u>MUST</u> register their chosen npo/ngo organisation on intranet site for FRV approval before claiming

System checks that team's last bank recon has been uploaded, if not team cannot claim, system prompts user



FCC Accounts Payable process and deposit into relevant volunteers account

Utilising the money – the controls in place

Policy : No CASH donations to registered non-profit organisations. Volunteers purchase what organisation needs with funds from FirstRand. No reimbursements from volunteer accounts to staff members.
